It is to confirm that, the area already proposed for diversion i.e. 2.5315 Ha of forest land is enough to accommodate / fit the proposed EUP @ Ch 266+960 and does not required further additional forest land.

Further, the detailed comments on the issues raised in the site inspection report dated 17.05.2022 was already submitted as Annexure-II to PIU letter cited(10).The copy of the same is once again enclosed.

The subject project was awarded and the new contractor is on board and about 51.41 % physical progress has been completed except in 1.12 Km where 2.5315 Ha forest land proposed for diversion. This project is proposed/expected to be completed and opened to public likely by Sep.2023 Ha of forest land is enough to accommodate / fit the proposed EUP @ Ch 266+960 and does not require further additional forest land.

Further detailed comments on the issues raised in the site inspection report dated 17.05.2022 submitted by User Agency has been verified and same is enclosed.

Therefore, the compliance report received from the Deputy Conservator of Forests, Mangalore Division, Mangalore in 4 copies is herewith submitted along with connected records with a request to move the matter with the Government for further needful action.
