Justification for locating the project on forest land with details of alternative sites examined for the project as per provision of para 2.1 (vii) (3) of FC Act guidelines for avoiding / minimizing use of forest land:

It has been certified by the User Agency (District Education Officer, Subarnapur) that the forest area involved in the proposal (Construction of Adarsha Vidyalaya) is unavailable and barest minimum i.e. 10.275 acre (4.16 ha) of Revenue Forest Land identified in village Phathamunda under Rampur Tahasil of Sonepur District.

In view of the above, the details of the alternatives examined as per the provision made under Para 2.1 (3) of the Forest Conservation Act guideline and justification for location of the project on the present site is given as under:-

Site No.1: This site is located in Beheramal RF and situated at distance of 8 kms from Dunguripali. The density of the vegetation comes under Open Forest category.

Since, the site is in Reserve Forest and the density of vegetation comes under Open Forest Category, the selection of site for the above purpose is discarded.

Site No.2: This site is located in the Andharibanji PRF and situated at distance of 12 kms from Dunguripali. The site comes under Open Forest category.

Since, the site is notified under Section 4 (1) of Orissa Forest Act as a Proposed Reserve Forest and the density of vegetation comes under Open Forest Category, the selection of site for the above purpose is discarded.

Site No.3: This site is located in Phathamunda Mouza of Rampur Tahasil bearing holding No.234 and Plot No.25. The status of the land is Gramya Jungle and total area of the above plot is 15.093 acre out of which 10.275 acre (4.16 ha) has been identified for construction of Odisha Adarsha Vidyalaya (Model School). The site is suitable in view of communication facility for School Student of Dunguripali Rural area. The Tahasildar Rampur has certified that no other Govt. land in a single patch of 10 acre is available to meet the above purpose. The Collector, Subarnapur has also certified the decision taken by the Tahasildar, Rampur. Further, in the present site there is no existing tree growth which needs to be felled.

The object of Model School is to provide quality education to Rural Students from class VI to XII in CBSE Pattern including Hostel facilities, it is essential those sites should be suitable from communication point of view and other facilities. It would not be wise to spare the Reserved Forest and proposed reserve forest for the above purpose. Further, no other govt. land (non-forest land) is available as the report of the Tahasildar Rampur which has been duly certified by the Collector, Subarnapur. Considering all three alternatives examined, **Site No.3** is found to be the best suitable site and accordingly recommended.
