SITE INSPECTION REPORT OF C.A. AREA (7 HA.) FOR DRILLING LOCATION DGR UNDER DIGBOI FOREST DIVISION

A proposal (FP/AS/MIN/23241/2016) drilling location DGR has been received for diversion of 3.411 ha. forest land in Upper Dihing Reserve Forest, West Block under Digboi Forest Division for non-forestry purpose under F.C Act 1980. A joint inspection of 7 ha. Compensatory Afforestation plantation area against the said proposal was done along with D.F.O. Digboi, Range Officer, Lakhipather Range and User Agency on 2nd December/2022. The proposed CA area falls in Upper Dihing Reserved Forest, West Block and the Compartment No is 114. During the site inspection, it was found that the proposed CA area has thick ground vegetation and is mostly covered with shrubs, climbers and weeds.

Density : The whole area was surveyed and enumerated and approximately only 20 nos. trees were found in an area of 7 ha. which is very low for a semi wet evergreen forest and qualifies as open forest. The details of trees enumerated is attached along with.

Considering the above, the submitted CA area may be allowed to be afforested under CA for the above project.
