Subject: **Diversion of 4.7 ha of forest land in favour of HPPWD, for the construction of road from Kiari to Khinna (Kms. 0/00 to 7/820), within the jurisdiction of Solan Forest Division, Distt. Solan, HP. (Online Proposal No. FP/HP/Road/28558/2017).**

Kindly refer to your office letter No. FC/HPB/06/85/2022 dated 10-8-2022 on the above cited subject.

2. The point wise reply to the observation as raised vide your above referred communication is submitted as below:-

1. In this regard CF Solan has submitted that the concerned path was in existence since long importantly, before 1980. The same has been submitted by Gram Panchyat and copy of which stand uploaded against the additional information detail column of Part-I. In view of this, provisions of section 1.21 does not seem to be applicable please.
2. In this regard it is submitted that the site was reviewed by the RFO, Chail and RFO (WL) Dhalli. The proposed site is 0.50 Km from the Shimla Water Catchment Wildlife Sanctuary. The revised NPV as per directions MoEF&CC dated 6-1-2022 has already been uploaded in the portal.
3. The copy of administrative approval has been uploaded at Sr. No. 12 against the addl. Information detail column of Part-I.
4. The road has already been constructed hence, there is no need for alternative site, however, alternative were explored and same have been marked in KML file.
5. The beneficiary villages have been marked in the KML as per the information provided in Part-I, B. 2.3.
6. The revised KML with the detailed ERow and PRow with distinct colour and the layout plan with Carriageway, Paved Shoulder, Earth Filling, Drain,

- and Protection Work duly authenticated by the concerned DFO has been uploaded against the addl. Information detail column of Part-I.
7. The length and width of broken area and un-broken area have been uploaded at Sr. No. 1 against the addl. Information detail column of Part-I. However, detail of trees has been uploaded at Sr. No. 14 against the addl. Information detail column of Part-II.
 8. The muck dumping site has been marked in KML file in distinct colour and no trees are coming in the said duming site. Further, no private land is involved in the said proposal. However, the joint inspection report dated 12.4.2023 has been uploaded against the addl. Information detail column of Part-I.
 9. The dumping site is proposed in forest land and no tree is involved in the said site, a certificate in this regard is uploaded at Sr. No. 25 against the addl. Information detail column of Part-II.
 10. The details of the Muck Disposal sites as mentioned in the Muck Disposal Plan has been provided under Part-I, B. 2.4.
 11. The revised NPV bill has been uploaded at Sr. No. 19 against the addl. Information detail column of Part-II.
 12. The reclamation plan has been uploaded against the addl. Information detail column of Part-II.
 13. The certificate in this regard have been uploaded at sr. No. 30 against the addl. Information detail column of Part-I.
 14. The tree enumeration list showing the date of tree counting has been uploaded against the addl. Information detail column of Part-II.
 15. The user agency has submitted an undertaking in this regard and same is uploaded at sr. No. 14 against the addl. Information detail column of Part-I.
 16. The necessary correction/ revision have been made against the appropriate column of Part-II.
 17. In this regard it is submitted that the proposed site is 0.50 Km from the Shimla Water Catchment Wildlife Sanctuary. The undertaking as per directions MoEF&CC dated 7-6-2022 has already been uploaded in the portal.
 18. The geographical area of the district has been reviewed and revised please.
