The above proposal was submitted by this office vide Ref (1) letter dated: 01-02-2022 seeking Stage-I approval under the Forest (Conservation) Act, 1980 to the Government of Karnataka and by the State Government vide Ref (2) letter dated 24-02-2022 to the Central Government. In response to that, the Government of India vide Ref (3) has raised the EDS Query. The same was communicated by this office vide Ref (1) letter dated: 01-04-2022.

In response to the query raised by the Government of India, the replies are furnished by the Deputy Conservator of Forests, Bannerghatta National Park Division vide Ref (4) through the Conservator of Forests, Bengaluru Circle Vide Ref (5) to this office. The EDS replies are as follows:

- The recommendation of the Standing Committee of National Board for Wildlife is attached herewith for your kind reference.
- However, due to over sight 470 trees are mentioned instead of 1288 trees. Therefore, it is kindly be corrected as 1288 trees only and move the matter with the Government of India for according approval.
