

1.	With reference to reply submitted at S.No. (i), The state Govt. reported that the instant project is site specific in nature owing to mining of Iron ore. However, it is stated that the mine is located over pristine forest and in high conservation zone as per the DSS analysis carried out in the Ministry. Further, keeping in view the fact that the area is in the middle of a dense forest the proposal under section 2(iii) was rejected by the Ministry. The State has neither given any justification in view of the Para 7.8(i) of the consolidated guidelines, nor any new fact justifying the diversion at this stage has	a) justification for diversion at this stage:- At present the proposed Site Specific Project Chhotedongar Iron Ore Mine is not over pristine forest as it is located adjacent to one existing operating Iron Ore Mines (within 3 km radius) in the same vicinity, having leasehold area 192.25 Ha of other Company (M/s Jayaswals Neco Limited), for which GOI accorded approval on dated 18/01/2007 under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 vide order no 8-31/99-FC (Copy enclosed as Annexure-A). Further density of the proposed forest area remains 0.6 Copy of the letter in this regard is enclosed as Annexure-B

	been brought out.	<p>Maps showing the Proposed Mining Lease area and nearby operating Iron Ore Mine within 3.00 km radius is enclosed as Plate – I.</p> <p>b) justification in view of the Para 7.8(i) of the consolidated guidelines:-</p> <p>It is important to note that M/s Shri Bajrang Power and Ispat Limited (SBPIL) is having its registered office at Urla Growth centre, Raipur in State of Chhattisgarh and is one of the leading steel producer in the State of Chhattisgarh having total requirement of Iron Ore in the tune of 2.00 MTPA but there is only one captive Iron Ore Mines namely Shri Bajrang Iron Ore Mine located at East Bhanupratappur division, of North Bastar Kanker district, CG having production capacity of 1.00 MTPA only (Relevant page of Review of Mining Plan approved by IBM is enclosed as Annexure-C) and average annual production achieved @ 0.80 MTPA during last 5 years because of its very low grade Iron Ore deposit & less Reserve. The lesser availability of raw material particularly iron ore (about 40% only) hampers the targeted finished steel production and development of the state & nation. Hence to fulfil the requirement of raw material particularly Iron Ore @ 2.00 MTPA, this Chhotongar Iron Ore Mine is proposed for diversion.</p>
2.	<p>With reference to reply submitted at S.No.(ii), the state has not clearly specified whether the LOI is valid as on date or not. Moreover, the state has submitted an old letter dated 30.05.2017 issued by the Mineral Resource Department, Govt. of Chhattisgarh. In this regard, in view of the provisions of Section 10-A(2)(c), the state shall clearly specify whether a valid LOI exists as on date or not.</p> <p>Further, the State Govt. has not clarified whether the NOC has been sought/obtained from the Ministry of Mines highlighting/indicating that the validity of letter of Intent (LOI) given to the user agency is still valid as the time limit</p>	<p>The issue of validity of Section 10-A(2)(c) is pending consideration in the Hon'ble High Court, New Delhi. The court in the instant case of the applicant, the court has directed that cut-off date of 11 January 2017 would not come in the way of granting relief to the applicant. As such the LOI is not invalidated in view of the specific directions issued by the Hon'ble Court granting the reliefs of processing the case further. Copy of the directions issued by the Hon'ble Court is enclosed herewith as Annex-D.</p>

Further, the Cost Benefit analysis has not been submitted in the prescribed format. Moreover, old NPV rates have been taken into consideration. The CB ratio reported as 1:263.76 which is exorbitantly high. The State Govt. shall submit Cost Benefit analysis as per the prescribed format and details of proposed reclamation/back-filled area at the end of mine life.</p>	<p>a) Since the entire area is not fully explored in detailed (up to G-1) level, the Mining Plan has been prepared based on the existing available geo-science data and according to the approved Mining Plan. It is currently proposed to utilise 17.118ha. out of 57.00 ha. mining lease area at present stage and the balance unexplored area 39.882ha. is to be undisturbed including safety zone of 7.5m. strip all along the Mining Lease boundary. However the land use pattern expected to be changed after completion of exploration upto G-1 Level.</p> <p>In addition to the 17.118ha. the proposed road of 9.02ha. will be utilized for approach to the Mining lease area. The Sate Govt. shall submit comments in this regard.	Recently on dt. 27/08/2024 the site inspection was conducted jointly by Forest & Revenue Dept. of the state govt. in the Presence of Local People along with representative of applicant and found that the CA land in village Dumarkholi(patch-1) and Village Bata(patch-5) is free from encroachment & encumbrances at Ground Level. The Copy of "Panchnama" is enclosed as Annexure -J . The Proposed CA land solely belongs to Director of M/s Shri Bajrang Power and Ispat limited (SBPIL) as per R.O.R. Copy of ROR is enclosed as Annexure- K . To keep watch & ward of the land, temporary shelter for security / watchman has been made and Whatever infrastructure is visible in the Satellite Imagery are belonging to SBPIL, which are being used by the security guard/watchman deployed. This temporary structure will be handed over to state forest dept. or dismantled as per the advice of Forest dept. as confirmed by Project proponent.
