महोदय,

उपरोक्त संदर्भित आनलाईन प्राप्त प्रस्ताव के क्रम में अनुरोध है कि उक्त विषयक प्रकरण में भारत सरकार पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय कार्यालय देहरादून द्वारा लगाई गयी बिन्दु संख्या- 1 से 3 तक आपत्ति का प्रस्तावक विभाग द्वारा निराकरण कर प्रतिउत्तर आनलाईन/ऑफलाईन इस कार्यालय को प्राप्त हुआ है। जिसे निम्नानुसार महोदय की सेवा में प्रेषित की जा रही है।

The KML analysed and found that the village Tuleri has already been connected from the existing road, while the other village Nain can be connected along the existing bridal path from the other side in a way so that the number of trees to be felled can be reduced to its minimum. The State Government is requested to explore the possibility of alternate along with the existing bridal path in order to connect the village Naini and submit the detailed report.	प्रस्ताव विभाग ने अवगत कराया गया है कि बिन्दु सं० 1 के क्रम में उनके द्वारा जांच करायी गयी प्रस्तावित मोटर मार्ग के प्रारम्भिक बिन्दु में पडने वाला ग्राम तुलेड़ी पी०एम०जी०एस०वाई० द्वारा निर्मित मोटर मार्ग से जुड़ा हुई है। ग्राम तुलेड़ी के समीप जो मार्ग है वह पैदल मार्ग कटोर चट्टानी क्षेत्र से होकर गुजरता है। इस तरफ से मार्ग निर्माण के समय अत्यधिक विस्फोटक पदार्थों का इस्तेमाल करना पडेगा जिससे भू-स्थलन एवं अत्यधिक वन भूमि को नुकसान होने की प्रबल संभावना है। उक्त के अतिरिक्त ग्राम नैनी को जोड़ने हेतु उपयुक्त संरक्षण उपलब्ध नहीं है।
2.	The tree Enumeration detail is not clear because the number (tree count) mentioned in the documents uploaded as an additional document in online portal is differ from the number provided in online Part II at para 4. 
