

In this regard, it is, submitted that the Part-II has been revised up to 31/03/2023 and uploaded online on Parivesh portal against column No. 16 as well as in the district profile, the progress of Compensatory Afforestation has also been updated as on 31/03/2023 online against column No. 14 in the Part-II, please.

4.	Further the 12% @ of interest is required to be calculated from the date of violation in Penal NPV i.e. year 2000 as per GoI guidelines.
