I wish to state that in the reference 4<sup>th</sup> cited, Government has requested to resubmit the proposal along with the details of Compensatory Afforestation scheme as per provisions of guidelines under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 [previously called Forest (Conservation) Act, 1980] for further consideration of the proposal. Further, the District Forest Officer, Pudukkottai has stated that one Eucalyptus tree is to be felled. In this connection, clarify whether the said tree to be felled is a planted or spontaneous tree.

The District Forest Officer, Pudukkottai vide reference 6<sup>th</sup> cited has stated as follows and uploaded the details / documents in Parivesh Web Portal: -

- 1) Regarding Compensatory Afforestation scheme applicable as per Forest Conservation Rules 2022, so far, we are going to uploading the estimate for planting 100 saplings along with kml file of degraded forest area.
- 2) Felling of one Eucalyptus tree has been wrongly entered by the Data Entry Operator. Also, necessary instructions given to concerned Thirumayam Forest Range Officer to confirm the status. FRO after inspection confirmed that the above mentioned one Eucalyptus tree is not found in the area proposed by the User Agency.

The Chief Conservator of Forests, Trichy has forwarded the additional details submitted by the District Forest Officer, Pudukkottai vide reference 7<sup>th</sup> cited.

I enclose herewith the same and request that, the proposal may be recommended and forwarded to Government of India (Regional Office) for getting Stage – I approval for diversion of 0.165 ha of forest land for laying underground Optical Fibre Cable (OFC) to a length of 5490.66 m at 1 to 2 m depth and width of 0.30 m along the left side of road from Arimalam to Rayavaram across Sengeerai RF in Pudukkottai District in favour of M/s. Jio Digital Fibre Private Ltd, Chennai for a period of 50 years.



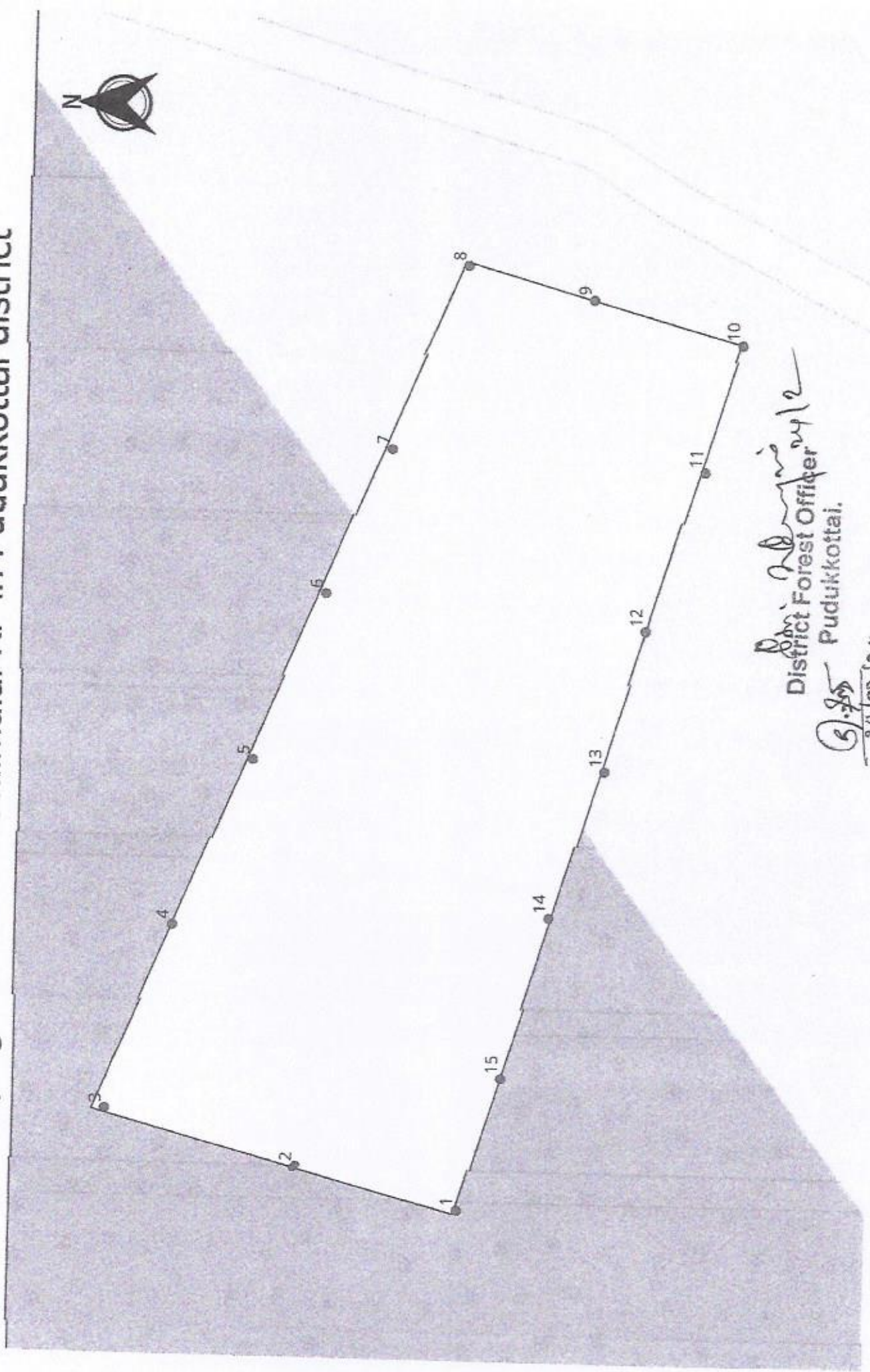
