- (i) Layout Plan of project with area dimension on real scale is attached at Annexure-I.
- (ii) KML file of Λ C Λ site is uploaded and Λ C Λ area details is attached at **Annexure-II.**
- (iii) NOC from DTP not required as project site is on this forest area only and undertaking of useragenacy for NOC from PPCB attached PPCB area are Attached at Annexure-III.
- (iv) The details of approach to main project site i.e. Naloh Tikka Palangi is shown in the Layout Plan for the Project. There are two approaches which are connecting to the main project site i.e. Naloh Tikka Palangi. The approach to the Kulara Island is through a bridge which is shown in the Layout Plan of the project. The approaches to the project site at kulara and Niloh Tikka Palangi are ultimately through road under the control of Punjab Mandi board. The approach to the Musharaba Island will be through boats.
- (v) Total area of Kulara Village is 46.65 acres. In which, 18.54 acre area will be used for this project. Balance 28.11 acre area of Kulara Island is not included in this project. DGPS Map of the Kulara Island is enclose at **Annexure IV**.
- (vi) The area of left out land just outside project site is attached at and it comes out to be 63.75 ha. The legal status of this land is Protected Forest and is being managed as per Working Plan.
- (vii) It is clarified that the land lying between the two proposed CA site is a Link Canal (Channel) and it is not a river. The management of this land is not with the Forest Department, it lies with Municipal Corporation, Pathankot.
