2. The point wise reply of the observations submitted by DFO Dharamshala is furnished as under:-

Sr. No	Query / Observation	Reply
1.	Has the CA area been uploaded on e-Green watch?	It is submitted that the Proposal is pending for Stage I Approval. The details of CA area to be uploaded on e-Green Watch Portal is available after the Stage-I approval is accorded for the particular Project. As submitted by the User Agency, the revised KML file having forest land proposed for diversion as 0.6806 ha has been uploaded on PARIVESH portal in online Part I.
2.	What happened to the reconciliation of area between 0.257 hac.and 0.68 hac.	It is submitted that in the KML file uploaded earlier, the components Water Conductor, Spillway, Penstock and Road were not in form of Polygon, so the area as per DSS Analysis (software calculated) was found to be 0.2570 Hac. Now all the components marked in the KML file are in Polygon form and the area proposed for Diversion comes to be 0.6806 hac. So there was difference in the CA Area as per the proposal and as calculated by the DSS Analysis in the KML File.

It is therefore, requested that the necessary approval for the diversion of 0.6806ha of forest land for the construction of above mentioned project may kindly be obtained from the Govt. of India under Forest (Conservation) Act, 1980 and conveyed to this office.
