The rest of the road which is visible at the site is a path/mule road which has been constructed in the 1980 and in-fact at some of the places it is 3 meters Path and at some of the Places it is 5-6 meters Path/mule road according to Revenue record and as per the certificate given by the Pradhan, Gram Panchayat, Mandhol. No work of any kind has been done on the Forest Land by the Himachal Pradesh Public Works Department. Also the Private Land has been gifted by the Local Villagers for the construction of said Road. Copy of the undertaking of the User Agency i.e. HPPWD and certificate of Pradhan, Gram Panchayat Mandhol have also been uploaded by the Use Agency through online in the Additional information Details in the Part-I as "regarding road undertaking and violation" respectively. Therefor keeping in view of the above backdrop there seem no violation in the present proposed land, please.
