With regard to the above subject and the proposal submitted under Forest (Conservation) Act, 1980 seeking Stage-I approval under Ref (3) letter dated 07-01-2019 and Ref (2) letter dated 21-05-2019, the Government of India vide Ref (1) letter dated 19-06-2019 (and further reminder) has sought the **Site Suitability Certificate** for the degraded forest land selected for Compensatory Afforestation along with a detailed **CA Scheme**.
