Adverting to the instructions of the Prl. Chief Conservator of Forests, AP. Guntur in the reference 2nd & 3rd cited, it is submitted that, the Divisional Forest Officer, Chittoor West in the reference 4th cited has submitted report to the two (2) points required by the GOI in the reference 2nd cited. The same is submitted below for favour of information.

1. The UA replied that, while uploading the online application regarding "Formation of Reservoir across Gangamma Sirassu Vanka near Nalagampalle (V) Palamaner (M) including diversion structure "as Linear instead of Non- Linear" by mistake. Hence, the UA requested to consider the above project under "Non – Linear" only and copy of the same is submitted for favour of kind perusal and record.
2. Regarding point No. 2, it is submitted that, there is difference in the shape of map available in the DSS analysis web site and as per the diversion records, the proposed project area is falling 1.50 Kms away from the boundary of Koundinya – Wild Life Sanctuary. Further as per the proposals submitted by the DFO, Chittoor West, vide Rc. No. 759/2012/A5, dated: 27.01.2013 for Notification of Eco-Sensitive Zone of KWLS and minutes dated: 14.01.2012 (copy enclosed) signed

by the District Collector, Chittoor is comprising of all forest & non forest areas up to 1 Kilometer, distance only from the existing of Koundinya Wildlife Sanctuary.

3. The UA i.e., Executive Engineer, Irrigation Division, Palamaner has furnished Wildlife Conservation Plan at Cost of Rs 77 lakhs for the improvement of habitat and the same is signed and enclosed herewith.

Further, the DFO, Chittoor West has requested for forwarding the above report to the Government of India for approval of the project.

In view of the above, it is requested to kindly forward the above report submitted by the DFO, Chittoor West to the Government of India for getting approval and communicate orders.
