Subject: **Diversion of 0.4654 hectare (instead of 0.5959 ha) in M/s Pharari Power Pvt. Ltd., House No. 99, Ward No. 8, Dhalpur, H.P. for the construction of Pharari SHEP (2. MW) within the jurisdiction of Kullu Forest Division, Dist. Kullu, Himachal Pradesh(OnlineProposal No. FP/HP/HYD/41259/2019).**

Sir,

Kindly refer to your office letter No. 8B/HP/01/70/2020/FC/935 dated 13.08.2020 on the subject cited above.

2. In this context, it is, submitted that user agency has changed location of the dumping sites from forest land to private land. Accordingly the user agency has revised the proposed diversion area to 0.4654 hectare (instead of 0.5959 ha) to use the minimum use of forest land and avoid unnecessary felling of trees. Further, reply to the observations as raised vide your above referred communication is submitted as below:

1. The village wise breakup, three villages have been mentioned. Pharadi village falls in Pichhlihar Panchayat, Runga-2 village falls in Hurang (Fozal) Panchayat, Meha village falls in Dwada Panchayat and NOC from Pichhlihar and dwada Panchayats have been obtained. The NOC from third Panchayat Hurang (Fozal) is placed in the fresh proposal folder at Page No. 42.
2. There are three Forest Right Committees in three Mohals. The Mohal, Pharadi of Phichhlihr Panchayat issued FRA certificate for 0.3766 ha. But, after correction made in Revenue papers, in this Mohal, diversion of forest land required is 0.2802 ha only.
3. Supplementary IA is placed in the proposal folder at Page No. 47-50.

4. In this regard, it is submitted that now only 3 number of dumping sites have been proposed over forest land & no trees are coming in the alignment of dumping sites proposed over forest land.
5. The plantation scheme of 1192 trees by way of CA has been placed in the proposal folder at Page No. 28-39.
6. The details regarding capacity has been filed at Para M (i) in online Part-I.

3. The proposal folder for the diversion of 0.4654 hectare of forest land (instead of 0.5959 ha) is enclosed herewith for further necessary action.
