( Sub: Diversion of 211.8427 hectare of forest land for the construction of Dugar Hydro Electric Project (500 MW) in favour of NHPC within jurisdiction of Pangi Forest Division, District Chamba.)

With reference to CCF Chamba Office Letter No. D-V/594/G/4351 dated 19.10.2021 regarding above cited matter , please find point wise replies to the observations as follows:

- Point No. 3: Reply: As per the online proposal against Part-II, total 3929 number of trees (above 30 cm) of various species and class are mentioned at Full Reservoir Level (FRL). However, 3873 and 3815 number of trees of various species and class are mentioned at FRL (- 2) M and FRL (- 4) M respectively. Trees enumeration list and abstract of trees duly signed is placed in the Forest Proposal from page No. 135 to 140. However, total enumeration list of 20777 number trees (above 10 m) of various species and class at Full Reservoir Level (FRL) are enclosed for kind information. Felling of trees shall be required for the area submerging upto Full Reservoir Level (FRL) and the area falling under other project components. However, felling of trees falling under project components shall be taken up as per actual requirement at site.
- Point No. 5: Reply: Necessary change in the requirement of non-forest / private land from 11.79 ha to 8.78 ha. has already been submitted by the user agency vide their letter No. NH/DHEP/277 dated 11-10-2021.
- Point No. 8: Reply: Digital land use map proposed for diversion of Forest land for Project and proposed for CA area is enclosed at Page No. 32 and 143 .
- Point No. 3: Reply: The details of proposed road along with map of the proposed road is attached at page No. 182 and 183 by the project. Road network has been proposed over an area of 8.168 ha of Forest land with total road length of 5445 m and width of 15 m required for the Project.
- Regarding revision of CA Scheme for 10 years : Reply :- Further CA scheme has been revised and prepared for 10 years and the The cost for CA Scheme has been revised considering maintenance for 10 years and placed at page No. 159-160 .

After attending to the observations the Proposal is resubmitted for further action at your end please
