

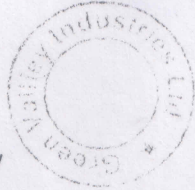
Therefore you are requested to conduct a site verification from your good office for further processing of our application.

With reference to the subject cited above and in compliance of the direction issued during the inspection carried by Conservator of Forests(T)Khasi & Jaintia alongwith the undersigned, the User Agency has been directed to erect the boundary pillars all along the proposed site of limestone mining project (Block-2) located at Madan Pyrda Chiehruphi village in East Jaintia Hills and approach road to the mining site.

In compliance of the above, the User Agency concerned have constructed the Cement Concrete pillar of 4fts height at the mining site and approach road inscribed with serial numbers, GPS-Cooordinate alongwith the forward and backward bearing of the adjoining pillars. The same has been inspected by this office and found to be erected as directed this office. The inspection report submitted by the Assistant Conservator of Forests(T) alongwith the photographs are enclosed herewith for your kind reference. Hence, the same is recommended for further necessary action at your end towards granting the Forest Clearance under Section-II of Forest Conservation Act, 1980.
