May provide/upload scanned copy of GIS software generated geo referenced digital map to the exact scale of the proposed road showing geo coordinates at 200m to 300m interval along the alignment including all turning points. 2	As per DSS (Decision Support System) Analysis out the Total area of 12-90ha proposed for CA. In DSS analysis are calculated only 10.79ha. Out of which 2 ha in one patch of 5.39ha is on Moderately dense forest State govt.State Govt may replace this 2ha area with some other area suitable for CA and provide/upload revised digital map.SOI toposheet map and KML file of the complete 12.90ha CA area again making the above change.
