Proposal for diversion of 0.890 ha of Revenue Forest land for Establishment of Mayurbhanj College of Accountancy and Management, Baripada in Baripada Forest Division in the District of Mayurbhanj.

In inviting reference to the letter on the subject cited above, I am submitting herewith the point wise compliance and supporting documents for favour of your kind information and necessary action.

Observations a- The DFO, Baripada has reported that the area proposed for diversion i.e., 0.890 ha already in use since 19.11.2003. the Hal Kissam of the area is found to be Patit (Non-forest), but the Kissam of land as on 25.10.1980 is Jungle-I/II/ Forest. The details of action taken report on violation may be furnished.

Compliance The Additional District Magistrate, Mayurbhanj has submitted the action taken report of the Tahasildar, Baripada vide letter No. 3748/ Rev date 30.12.2024. A copy of the report is enclosed as Annexure-I for your reference.

Observations b- "A Site Selection Committee was held on 05.06.2002 in the office of Collector and District Magistrate, Mayurbhanj for selection of site for different projects including Mayurbhanj College of Accountancy and Management. However, who has allotted the instant proposed land has not been reported by the State Govt".

Compliance The Additional District Magistrate, Mayurbhanj has submitted a detailed report from the Tahasildar, Baripada, vide letter No. 3748/Rev dated 30.12.2024, along with its enclosures. A copy of the report is enclosed as Annexure-I.
