

In compliance of the Ministry of Environment and Forests (MoEF), Government of India letter No. 11-9/98-FC(Pt) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of Rights under the Schedule Tribes and Others Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 0.98 hectares of forest land proposed to be diverted in favour of Department of Tourism, Manipur for the project "Development of Integrated Mega Tourist Circuit for Khebaching in Manipur" in Thoubal District falls within the jurisdiction of Samaram Gram Panchayat, Thoubal C.D. Block under SDC, Khongjom Circle of Thoubal Sub-Division.

It is further certified that

- a. There is no Forest Dwelling Schedule Tribes, Pre-Agricultural Communities, Primitive Tribal Groups and Other Traditional Forest Dwellers in the proposed diversion of 0.98 hectares of Forest land at Khebaching in favour of Department of Tourism, Manipur.
- b. The Forest land proposed for diversion by Director (Tourism), Manipur is located at Khebaching and lies within the jurisdiction of Samaram Gram Panchayat, Thoubal C.D. Block under SDC, Khongjom Circle of Thoubal Sub-Division.
- c. The Samaram Gram Panchayat, Thoubal C.D. Block has certified that there is no Forest Dwelling Schedule Tribes, Pre-Agricultural Communities, Primitive Tribal Groups and Others Traditional Forest Dwellers in the proposed area of Khebaching and the Gram Panchayat has not received claims for recognition of forest rights under the Scheduled Tribe and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.
- d. The Samaram Gram Panchayat, Thoubal C.D. Block has no objection to the diversion of forest land measuring an area of 0.98 hectares at Khebaching in favour of Department of Tourism, Manipur for the non-forest purpose namely "Development of Integrated Mega Tourist Circuit for Khebaching in Manipur", which falls within the jurisdiction of Samaram Gram Panchayat, Thoubal C.D. Block under SDC, Khongjom Circle of Thoubal Sub-Division, Thoubal District.

Clarification sought by Forest Department on "Diversion of 0.98 ha of forest land for Development of Integrated Mega Tourist Circuit for Marjing polo – Kaina – Khebaching (Construction of War Memorial at Khebaching, Khongjom) in Manipur by Tourism Department".

Sir,

As desired the clarification on the para 2(iii) of the attachment to your mail (copy enclosed) on the above subject, the following clarifications are placed:

- That the Khongjom War Memorial was developed by the Government of Manipur and inaugurated by the the His Excellency, the President of India, Shri V.V. Giri in the year 1973. This memorial is being developed by the Government of Manipur in a grand scale and convert it to a big tourist attraction place. The whole complex is enlarged hugely with development of lakes/water bodies, plantation of trees, development of landscaped garden, construction of very tall towers, construction of internal roads etc.
- 2. The 260 m long road is an existing road, which is part of the already existing memorial inaugurated by the then President of India in 1973.
- 3. The 240 m long new cutting road is part of the expansion programme of the Memorial complex and unavoidably required to integrate the whole complex, as it is the missing link. It will serve as a peripheral road and also segregate the complex from the hillock occupied by the Assam Rifles.
- 4. A copy of the Master Plan of the Complex is enclosed to understand the requirements.
