

- (i) Relevant records pertaining to non-forest land, revenue lands, *zudpi jungle, chhote jhar ka jungle, bade jhar ka jungle, jungle-jhari land, civil-soyam* lands and all other such categories of forest lands (except the forest land under management and administrative control of the Forest Department) on which the provisions of Forest (Conservation) Act, 1980 are applicable, available in each district of Manipur (name of State/UT) have been examined; and
- (ii) I have also conducted such further enquiry as is required to satisfy myself for issue of this certificate.
