Subject: Proposal for diversion of 145.60 ha of forest land for construction and stringing of 132 KV transmission line from Khengjang to Thanlon in Churachandpur District, Manipur by Manipur State Power Company Ltd.

With reference to letter F.No. 3 MN C 006/2016-SHI/244-46 dated 22.04.2016 on the above subject and in compliance of the observation of REC made in its meeting held on 15.04.2016, I am to furnish herewith the following information/document for further necessary action.

1)	To propose new compensatory afforestation location in place of 35 ha proposed in Kailam WL Sanctuary and to submit the SOI Toposheet showing the location of the new C.A. area with the G.P.S co-ordinates along with the soft copy and hard copy of the KML/shape files or to certify by the Chief Wildlife Warden that the proposed CA location in Kailam Wildlife Sanctuary is a part of the approved Management Plan.	New compensatory afforestation location sites and other required information are indicated in Para (2), Column- 3 below.
2)	The C.A. site at Cheklaphai R.F.(128 ha) should be revised by segregating the blank degraded area from it and identify some plank/degraded area in place of the forested area and accordingly provide SOI Toposheet showing the location of the revised C.A. area with the G.P.S co-ordinates along with the soft copy and hard copy of the KML/Shape files.	The CA area proposed earlier at Tangpizawl Centre (Compt. No. 8 Cheklaphai R.F.) was over 128 ha degraded forest. However, as observed by the REC only 53 ha over the blank degraded is proposed. 2 (two) new CA sites are proposed at Thingngchom (Compt. No. 17 Dampi RF) over 55 ha and at L. Molhoiphai (Compt. No. 39, Dampi RF) over 55 ha. The SOI Toposheet showing the location of the revised C.A. sites with the G.P.S co-ordinates along with the soft copy and hard copy of the KML/Shape files are enclosed.



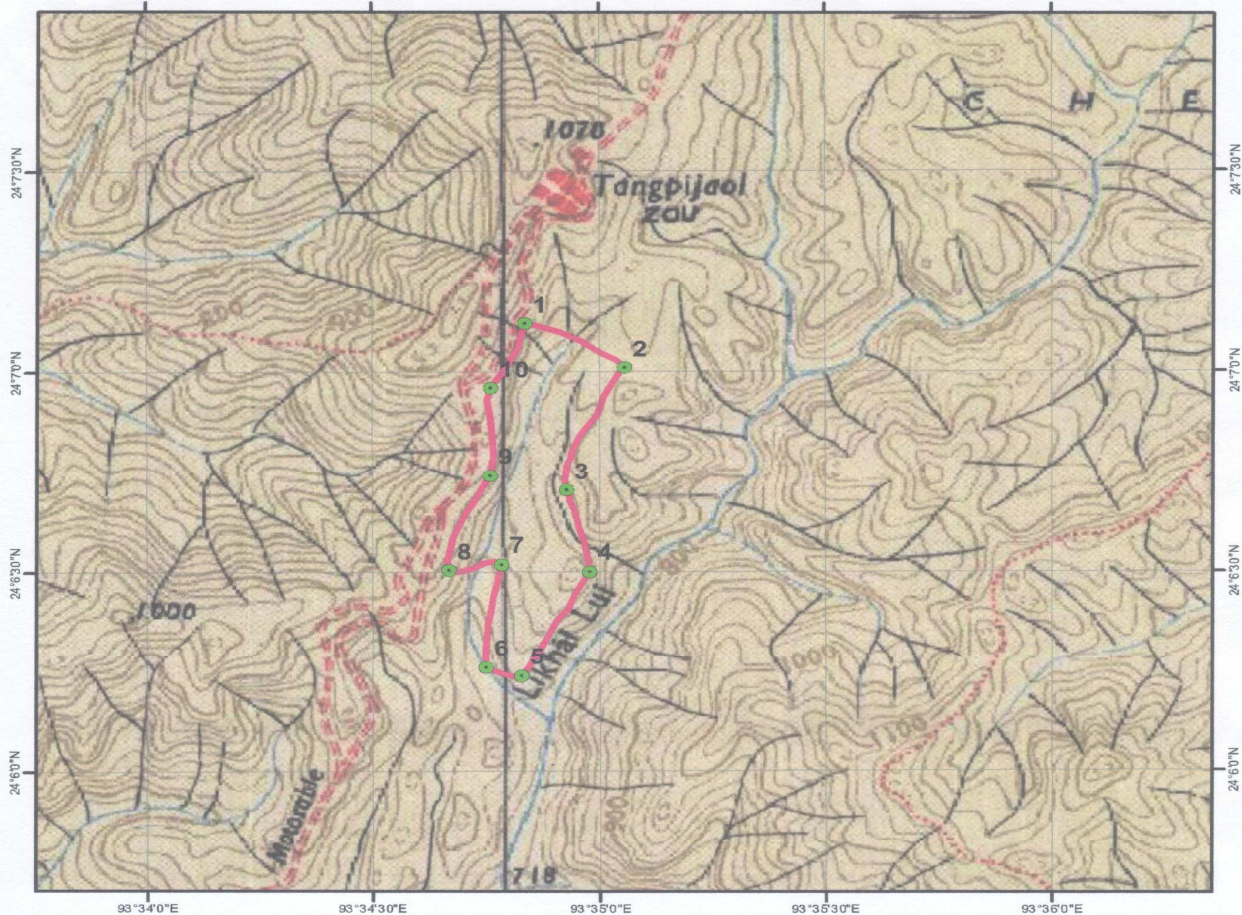
