2.	No correction regarding legal status of DA has been found done in the portal. The legal status of DA mentioned in Part-II is still mismatching with the Part-II under Sr. No. 5.	The necessary correction has been made in Sr. No. 5 of Part-II.
3.	The approved and proposed project has not been marked in distinct colour in KML file.	The revised KML file has been uploaded against column No. C 2(a) (I) on the portal by the user agency in Part-I also the KML file has been submitted through e-mail to nodal office on his official e-mail ID:- nodalcfahp@yahoo.com on dated 28/08/2024 at 4:39 PM.
4.	No CD as per reply has been found attached.	Two Nos CD's has been attached with this letter.
8.	The recommendation letter of DFO under Sr. No. 16 of Part-II is still blank. The Part-II uploaded as additional information can not be considered as it has mismatch of legal status of DA. The documents may be uploaded in the appropriate column.	The recommendation letter of DFO has been uploaded as additional information. Due to technical error in Parivesh 1.0 the proposal has not shown in the Para-16 of Part-II, hence unable to upload the same. The legal status of DA has been changed accordingly.
