The current status is that no response has been received in CCF's office from court of CJM against three (3)
O/R dt. 12.1.2022, 7.3.2023 and 25.1.2023 submitted by DFO Anjaw to him. The O/Rs, violation reports etc as
forwarded by DFO Anjaw to CJM Anjaw have already been enclosed with this office letter No. EAC/Cons-
291/2022/575-78 dt. 10.3.2023.

CCF Tezu vide his No. EAC/Cons-291/2022/575-78 dt. 10.3.2023 informed NO (FCA) that the O/R etc
submitted by DFO Anjaw vide his letter dt. 9.3.2023 against RWD for an offence allegedly occurred in 2009
may not stand the scrutiny of law due to lapse of time and may be a futile exercise.

		Further, as regards officials of SFD, the DFO Anjaw has given names of DFOs around 2009 but has said that no detection of violation was done in 2009 so no action has been taken against forest officials yet. The DFO Anjaw in his note on violation { (already submitted to NO (FCA) }has stated that Shri K. Pertin (expired) was DFO of undivided Lohit FD including present Anjaw FD and Shri AK Deka DFO Anjaw while also stating that no records of violation of FCA by RWD for PMGSY km 158-165 was found in his office files so no action had been taken against any SFD officials for construction of PMGSY km 158-165 HMH road if the road was constructed in 2009 till date.
(ii)	In the violation report submitted for 3.5 Ha at Sl. No. (9), the violation is still continuing. State Govt to take action immediately as per IFA, 1927 & FCA 1980 and submit current report of the same.	25.1.2023 has been drawn by RO Hayuliang and violation report etc has been forwarded by DFO Anjaw to CJM Anjaw vide No. ANJ/Cons-36/2021/373-76 dt. 9.3.2023. The detailed report forwarded to NO (FCA) vide No. EAC/Cons-291/2022/575-78 dt. 10.3.2023 highlighting the fresh third violation over 3.5 Ha by present UA (GREF) while directing the UA to refrain from 6 dt.
(v)	The existing RoW of the existing PMGSY road (158.00 to 165.00 km) and proposed RoW	The width of existing PMGSY is usually 6 mtr so the violation over 158 to 165 km (7 km x 6 mtr = 4.2 Ha) as per norms has been calculated by concerned RO/ DFO whose reports may be referred. But since no FCA for PMGSY road was found by the UA so UA has applied for the entire 24 mtr width RoW over 7 km length = 16.80 Ha from 158 to 165 km length for widening of existing PMGSY road plus 1.80 Ha for MDPs.


