

Site Inspection Report of Divisional Forest Officer, Nagaon South Division, Hojai:

(For proposed Kalamonijan Irrigation Scheme)

A Proposal (Reference No. FT/AS/IRRIG/38072/2019) has been received for Diversion of forest land 0.57 Hect. for non-forestry purpose under FC Act. The proposal has been received from the Jamuna Comand Area Development Division by the Nagaon South Division, Hojai. The area was jointly verified with the officer of Irrigation Department, Hojai, and found that, the proposed 0.57 Hect. forest land is required by the User Agency for laying out irrigation pipes on both the side of the road upto the length of the pipe line is 877.49 mtrs. & one side of the road covering 440 mtrs. of length passing inside Hawaipur RF. The total length of the pipe lines inside RF area is 877.49 mtrs. x 2 + 440 mtrs. = 2194.98 mtrs. The area cover for the purpose is 2194.98 mtrs. x 2.6 mtrs. = 5706.948 sqr. Mtrs. = 0.57 Hect. The area is a barren forest land.

Necessary of irrigation scheme is highly essential for local society. Moreover, no tree is to be felled for laying out irrigation pipes passing through the Hawaipur RF.
