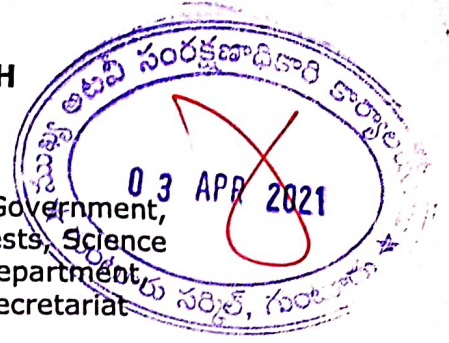

The available quartz in the area is glassy variety and finds uses in glass semiconductor industry and ferroalloy industries.
