I submit to state that the omissions pointed out by the Principal Chief Conservator of Forests in reference 5th cited above are furnished as follows:

(i) From the 3rd year maintenance to 10th year maintenance period, cost estimate arrived for the amount proposed in the abstract of CA scheme is furnished.

(iii) The work cost estimate for chain link fencing work based on Current PWD SSR 2022-2023 year rate is prepared and furnished.

As regards to Chain link fencing the PWD SSR of 2018-2019 was previously adopted , now it has been estimated with reference to 2022-2023 PWD SSR and the total estimate cost works out Rs.8,73,620 and also the total cost for raising Compensatory Afforestation over an extent of 1.52Ha in degraded Forest land comes to Rs.32,75,500


Under the Circumstances i request that the revised proposal may kindly be considered and Accepted.
