Sub: Diversion of 0.8148 (revised from 1.4406 hectare) of forest land in Ubbalagundi Extension Reserved Forest, Ubbalagundi village, SandurTaluk, Ballari District for Approach Road to Ubbalagundi Iron Mine ML No.008 (located partly in adjoining Donimalai Block Forest and partly in Ubbalagundi Extension RF) in favour of M/s JSW Steel Limited, Tornagallu

With regard to above, the proposal was submitted by this office vide Ref (1) seeking Stage-I approval under the Forest (Conservation) Act, 1980 to the Government of Karnataka and by the State Government vide Ref (2) letter dated 13-10-2022 to the Central Government. The Government of India vide Ref (3) has stated that "the area proposed for diversion was inspected on 16.11.2022. During the site inspection it came to notice that there is already a road to the instant mine which is primarily passing through the non-forest land and was being used by earlier lessee. The existence of non-forest alternatives was not even mentioned in the proposal. The FC Act and Guidelines envisage that the existing non-forest land should be the priority for use, and forest land should be considered only in case of non-availability of forest land. Therefore, it is requested to re-examine the proposal for approach road in forest land and the user agency/ State authorities may be directed to use the existing road in the non-forest area, as the same road were used by the earlier lessee also.

It was learnt that similar proposals for approach road in forest area are in the pipeline, inspite of existence of roads through non-forest lands. Hence, the matter may be suitably decided by the State Government instead of leaving the issue of approach road decision to the user agency and proposal for use of forest land when suitable non-forest alternatives exist, against the tenets of forest conservation laws."

In this regard, this office vide Ref (1) letter dated 26-12-2022 directed the Chief Conservator of Forests, Ballari Circle to communicate the above to the concerned jurisdictional Deputy Conservator of Forests to re-examine the proposal for approach road in the forest land. Further, the Chief Conservator of Forests, Ballari Circle communicated the same to the Deputy Conservator of Forests, Ballari Division subsequently to the User Agency to re-submit the proposal for approach road as suggested by the Government of India.

In response the User Agency vide Ref (4) letter dated 13-02-2023 has agreed for using the existing approach road and has revised the proposal from originally proposed 1.4406 ha to 0.8148 ha. The same has been verified by the field officers and the reply to Government of India EDS query has been uploaded on FC web portal vide Ref (5) & (6) on FC web portal.

Based on the reply submitted by the User Agency through field officers as above, a revised proposal seeking diversion of 0.8148 ha (instead of originally proposed 1.4406 ha) forest land in Ubbalagundi Extension Reserved Forest, Ubbalagundi village, SandurTaluk, Ballari District for Approach Road to Ubbalagundi Iron Mine ML No.008 (located partly in adjoining Donimalai Block Forest and partly in Ubbalagundi Extension RF) in favour of M/s JSW Steel Limited, Tornagallu is being revised as below for forwarding to the Government of India as reply to its EDS query dated 09-12-2022.
