



The undersigned is directed to refer to letter dated 30.04.2025 (copy enclosed) received from Ministry of Environment, Forest and Climate Change on the subject mentioned above wherein the comments of Ministry of Mines have been sought in the matter keeping in view the Section 10A(2)(c) and other provisions of MMDR Act.

- 2. The matter has been examined in the Ministry and it is observed that in the instant case the Letter of Intent for grant of mining lease for mineral iron ore was issued by the State Government in favor of M/s Gopani Iron & Power (India) Pvt. Ltd. on 04.09.2006. Therefore, the instant case falls within the ambit of Section 10A(2)(c) of the MMDR Act.
- 3. As per the provisions of Section 10A(2)(c) of the MMDR Act and Rule 8(4) of the Minerals (Other than Atomic and Hydro Carbons Energy Minerals) Concession Rules 2016, mining lease in the instant case was required to be executed and registered within a period of two years from the date of commencement of the MMDR Amendment Act, 2015 i.e. on or before 11.01.2017. However, the mining lease in the instant case has not been executed.
- 4. In this instant case Govt. of Maharashtra have already issued letter for validation of LOI on 19/12/2023 in which they have clearly stated that "LOI is still valid" as per the direction of Hon'ble Hight court Mumbal bench nagpur dt. 06/01/2017 & 12/09/2017.
- 5. In view of above, the Letter of Intent issued by the State Government on 04.09,2006 is valid.



Kindly refer to your letter mentioned above, it has been requested to State Govt. that, the Ministry of Environment, Forest and Climate Change, Govt.of India has sought information from your on the status of validity of "Letter of Intent" along with relevant details, therefore communicating the following details and status of this issue.

It is inform you that, prior permission was obtained from the Central Government vide 01/06/2006 for allotment of the subject mining lease in favor of your company. On the basis of this prior approval of the Central Government, "Letter of Intent" was issued to Gopani Iron and Power (India) Pvt.Ltd. dated 28/06/2006 and 04/09/2006 subject to terms and conditins like environmental clearance, forest department clearance and mining plan approval within six months.

In this Matter Hon, ble High Court on dated 06/01/2017 passed following order, "By way of interim order, we direct that the proposal of the petitioner shall not lapse till next date." And dated 12/09/2017.....

"Facts in the present matter show that on 15/10/2004, application for Mining Lease was moved and respondent No.3 recommended it on 27/12/2005. On 01/06/2006, respondent No.1- Ministry of Mines accorded approval under Section 5(1) of Mines and Minerals (Development and Regulation) Act, 1957. On 04/09/2006, an order was also passed for granting it subject to Environmental Clearance and approved from the Forest Department. The Environmental Clearance was given on 13/10/2008.

When the provisions of above mentioned Act were amended in January, 2015 the only forest clearance was under consideration.

At the state, it is not in dispute that the Forest Advisory Committee has on 25/04/2017 looked into the case and recommended the petitioner's proposal for approval under Section 2(iii) of Forest Conservation Act, 1980. Reply filed by respondent No.2 before this Court brings on record subsequent developments. The Minutes of Meeting of Forest Advisory Committee dated 28/07/2017 reveal that because of Guideline 2.1 (VI) contained in Manual which advises the State Government not to consider / process cases, which are pending in various Courts or su judice to avoid all sorts of administrative legal complication; the Forest Advisory Committee thought it proper to recommend in negative i.e. not to grant permission to the State Government under Section 2(iii) till final orders of High Court on applicability of provisions of Section 10-A (2)(c) of the Amended provisions.

In the present matter, respondents do not dispute that the Letter of Intent (LOI) has been issued to the petitioner on 04/09/2006. In view of this position, it is apparent that the favorable recommendation to the Forest Advisory Committee dated 25/04/2017 needs to be looked into on merits by respondent No.1 and pendency of petition before this Court cannot be a ground to postpone it. Accordingly, we direct respondent No.1 to consider that recommendation on merits, within a period of three months from today. With these directions, we partly allow the Writ petition and dispose it off. No order as to costs.

In this context it is to mention that, out of the permission to be obtained by the Company, which was mentioned in the Letter of Intent, only NOC from the Forest Department of the Central Government is yet to be obtained.

In view of above context and as requested by the Central Forest Advisory Committee vide its letter dated 26/10/2017 and as per the order passed in Writ Petition No.126/2017 dated 06/01/2017 and dated 12/09/2017. In this context the Mining Department has examined the matter carefully whether the Letter of Intent is still valid or not. After examining the case in detailed, it is to convey you that the Letter of Intent issued by the State Govt. is still valid. Therefore, you are requested to submit the required clearances i.e. Forest Clearance to the State Govt. so that to further process the matter for issuance of Mining lease for Iron Ore block.
