Sub :- Diversion of 18.458 Ha Forest land for the construction of new 110KV D/C line in the existing 110KV Mahalingapura to Jamkhandi S/C line Corridor for a distance of 23897 Kms infaour of Exective Engineer (ELE) Major Works Division, KPTCL Bagalkot - reg.

Ref :- Proposal No. FP/KA/TRANS/16981/2017 received from DCF, Bagalkot through OSMFCP, on 16-10-2018.

With reference to the above subject, the Deputy Conservator of Forests, Bagalkot Division, Bagalkot has submitted the necessary proposals through OSMFCP, for Diversion of Forest land for the construction of new 110KV D/C line from 220 KV. Mahalingapura to Jamkhandi Substation in the existing 110 KV SC line Corridor along with 100 KV Terminal Bays at both ends for a distance of 23.897 kms.

Details of forest land proposed for diversion is as under.

The DCF, Bagalkot has inspected the spot on 23-03-2018 and has observed that the proposed area falls in the limits of Scrub and degraded forest land. He has further reported that the project does not affect any monument of historical, recreational, archaeological importance. It is not a part of National Park or Wildlife Sanctuary. The DCF, Bagalkot submits that the forest land demanded for the said project is barest minimum.



He has also reported that the provisions of the Forest (Conservation) Act-1980 are not violated in this case.

Degraded forest land to an extent of 36.916 ha. for the purpose of compensatory afforestation is identified in F.S.No:42 Jamkhandi Village Jamkhandi Range. Detailed scheme for Compensatory Afforestation will be obtained from the Deputy Conservator of Forests, Bagalkot and will be submitted at the earliest.

The DCF, Bagalkot has processed the proposal and recommended for acceptance. Agreeing with the recommendations of the DCF, Bagalkot, the proposal is recommended for acceptance for diversion of 18.458 ha. of forest land in Bagalkot Division for above said purpose.

This is submitted for favour of your kind perusal and necessary action in the matter.
