



### <u>Cumulative Impact Study for diversion proposal of Bheluguri,</u> <u>Lankaijuri and Beldenga Stone Mahal Area: Submitted by Internal</u> <u>Committee constituted under Nagaon Division, Nagaon.</u>

The entire project area of 15.65 Ha of Bheluguri, Lankaijuri and Beldenga Stone Mahal is forest land of Doboka R.F., and it with degraded forest with grass & shrubs. Nearest habitation is about 0.5 Km from the proposed area. The drainage pattern comprises of small streams carrying rainwater during rainy season. Presently, there are 3 numbers of approved Mining Areasand 3 numbers of under process proposals, the details of which are given in the table below.

### Cumulative Impact on the landscape due to Stone mining/Stone Mahals

(Ref: Environment Management Plan of all 3 New Mahals namely: Bheluguri, Lankaijuri and Beldenga Stone Mahal Area)

This study delves into the cumulative impact of stone mining on the landscape of Doboka Reserve Forest under Nagaon Forest Division. The assessment encompasses environmental, forest & wildlife, and economic dimensions, highlighting the need for sustainable practices. Moreover, the study proposes mitigation measures to address the identified impacts and promote responsible stone mining in the region. All 3 areas i.e.Bheluguri, Lankaijuri and Beldengaare in the foothills of Doboka RF which is mostly open degraded forest. Nearby forest area is also predominantly Teak plantation which is monoculture, therefore limited scope of loss of Biodiversity if mining is allowed there.

Probable impact on the Landscape/ecosystem due to pollution and hazards associated with stone mining.

Certain probable impact on the landscapewhich can occur due to unregulated and unethical mining practices can be highlighted as follows:

- Environmental Impact:
  - a. Deforestation and Habitat Loss: The expansion of mining operations might result in the clearance of forested areas, which may lead to habitat loss for flora and fauna.
  - b. Soil Erosion and Water Quality: Mining activities contributeimpacting the quality of water bodies in the region. Sedimentation in rivers and streams lead to long-term ecological repercussions.
    - c. Air and Noise Pollution: Dust emissions from mining activities and the use of heavy machineries, DG sets etc. contribute to air and noise pollution. Additionally, the constant noise generated can disturb the faunal population and negatively affect the well-being of nearby communities.
  - d. Vibrations due to blasting: Possible mild vibrations generated during blasting due to the use of explosives can disturb the faunal population.
- Measures to mitigate pollution and prevent any potential impact on the landscape:
  Implementation of a strict reforestation plan to compensate for the cleared areas, focusing on native species to restore biodiversity will be enforced to combat deforestation. (*Funding through Mines & Minerals Development, Restoration and Rehabilitation fund will be pursued for reforestation plan by forest department with permission of higher authority*)
  - Comprehensive Man-animal conflict Plan: Already proposed from this office ( *Fundingshall be given by User Agency*) which will enable frontline staff to smoothly handle man-animal conflict issues, especially human-elephant conflict issues which are seasonal in nature.
  - Regular water quality monitoring should be conducted to ensure non-infiltration of pollutants in the ground water and in the nearby water bodies, if any.(*Need to be complied by User Agency*)

- Possible impact on water bodies due to the domestic waste water generated from the mining is to be mitigated by sending the waste water to septic tanks and soak pit. However, as reported by User Agency in the submitted Mining Plan and Environmental Management Plan the proposed quarrying activities will not affect the ground water as the depth of ground water is around 20m bgl.(*Need to becomplied by User Agency*)
- For mitigating air and noise pollution- water sprinkling will be done for dust suppression using water tankers on dump yards and workers will be equipped with proper dust masks. Also, the DG sets will be provided with required stack height for proper emission dispersion. For high noise bearing equipment noise barriers, silencers and acoustic enclosures will be incorporated. (*Need to be complied by User Agency*)
- To control the impact of vibrations, use of low explosives with less quantity is advisable so that the vibrations generated are within the permissible limits. (*Need to be complied by User Agency*)

### Lack of Discernible Impact on the landscape (No adverse impact on the landscape and biodiversity):

The cumulative findings indicate that there will be no substantial impact on the landscape levels of the Doboka RF as a result of mining activities.

- <u>Minimal habitat disruption:</u> The clearing of land for stone mining / quarrying will be carried out with minimal disturbance to the natural habitats of plant and animal species. A significant reason for the lack of impact on the biodiversity is the careful consideration given to site selection. These areas have been chosen to minimize disruption to existing ecosystems. All the mining areas are in the foothills of Doboka RF which is mostly open degraded forest. The nearby forest area is predominantly Teak plantation which is monoculture, therefore limited scope of loss of Biodiversity if mining is allowed there. Minimum number of trees i.e. only 2 trees being felled in whole of projects as per the submitted Forest Diversion proposal from this office.
- <u>Protected habitats</u>: All landscape for proposed mining activities in Doboka RF is being located faraway from any core wildlife habitats. This has reduced the likelihood of direct contact or disruption to the fauna. Human-elephant conflict issues will be handled effectively by Comprehensive Man-Animal Conflict Mitigation Plan earlier submitted from this division. There is very limited movement of elephants observed in concerned area and with proper implementation of mitigation plan, conflict issues will be effectively handled in total.
- <u>Limited air pollution</u>: Emissions from machinery and vehicles used in these activities have been well within permissible limits, with no significant adverse effects on local plant life.
- <u>Minimal pollution and hazards due to the environmental regulations:</u> Stringent environmental regulations and guidelines enforced by the MoEF&CC, State Forest Department, Pollution Control Board etc. will contribute to minimizing potential damage to flora.

Thus, the stone mining activities in the Doboka Reserve Forest area will be conducted with a strong commitment to sustainable and responsible practices. The implementation of advanced technologies, environmental conservation initiatives, and community engagement strategies will ensure that there is no negative impact on the landscape. This approach will set an example for the integration of economic development and environmental preservation, showcasing the potential for responsible resource extraction in sensitive ecosystems. Continued adherence to these principles is, crucial for maintaining the ecological integrity of the Doboka Reserve Forest while supporting the local economy.
