The same was communicated by this office vide Ref (1) letter dated 08-08-2023to User Agency and Field officers for further action.

In response, Deputy Conservator of Forests, Mangaluru Division vide Ref (3) has submitted the information to the Chief Conservator of Forests, Mangaluru Circle who, after verification, vide Ref (4) has submitted it to this office.

1	1	About other technology available as alternatives to OFC cable installation and about the project requirement?	There is no other alternative technology available to replace fiber. The fiber technology is the latest and most advanced transmission method capable of carrying high — speed signals, especially for 5G technology. Therefore, the continued use of fiber is essential for efficient and reliable communication for this project.
		As the proposed work is to be carried out on the NH PWD road side, whether the land falls under NH-PWD or Forest Department?	22 yards on either side measured from the center of the road has been mentioned as public right of way in the notification of the Reseved Forest through which Jio optical Fiber cable passes.
			No document no ownership of this right of way is available.
	2	initia Grandous	It appears that it has been kept valid for road development and can be considered as reserved only for road development work.
			Therefore, apart from road development there is no proposal in the notification about using it for other development works, so the user agency has submitted a suitable proposal according to the Forest Conservation act 1980 for laying of jio optical fiber cable on the roadside of National Highway 73 – to the extent of 0.385 ha.
