With reference to the letter 3rd cited, it is informed that for the discrepancies noticed in the proposal uploaded on-line, the following action is taken in this regard.

Sl. No.	Discrepancies	:	Action taken
1.	Original copy of the RoFR certificate or copy of the RoFR certificate duly attested with official seal of the concerned competent authority needs to be furnished.	:	The copy of RoFR certificate attested with official seal of the concerned competent authority is sent herewith.
2.	Confirmation regarding uploading of list of trees enumerated in the bale designated for the same in part-II of the online FC application	:	The details of trees enumerated have been updated in the Ministry's web portal at Column No.3 of Part-II. The hard copy of the same is enclosed herewith.
3.	Details of the CA land i.e., CA map, DGPS co-ordinates, soil suitability certificate etc may also be updated please.	:	On this item, it is informed that a detailed reply has already been made to the Regional Office, Chennai in this regard vide PCCF's Ref.No.3445/2016/FCA-1 dated 05.01.2017. The same holds good. Soon after inclusion of editing facility in the web portal, action will be taken to upload and furnish hard copies.

Here it is informed that for uploading the CA land details individually for each project from a land bank of CA, there is no provision in forest clearance or e-Green watch portals. The National Informatics Center may be requested to make such provision which has already been requested. In addition to above, uploading of CA lands given combined or making provision to upload CA details separately and link it to a particular project also serves the purpose of land bank concept.

Further, as regards to uploading the details of trees enumerated in the Ministry's web portal, Sri R.K.Pathak of National Informatics Center was already requested to make provision for uploading the Excel Sheet during Work Shop conducted during November, 2015. The similar provision already exists for the projects uploaded or received prior to June, 2014. Further, the same was also requested to FSI and NIC during DSS training held during June'2016.

Mr. Pathak of National Informatics Center has promised that besides other facilities, this facility will also be provided in the online system. However, the same is yet to be provided. Hence, it is requested to make provision as early as possible, for early processing of forest clearances.

This is for information and necessary action.
