In this regard the proposal for the diversion of 50.091 ha. of forest land in favour of ITBP, for the construction of Dubling Rishi Dogri-Lamche Dogri Road from 0/00 to 25 Km by CPWD, within the jurisdiction of Kinnaur Forest Division, Dist. Kinnaur, Himachal Pradesh has been scrutinized by this office and the shortcomings/Reply Compliance for each of the Query raised by your office regarding the forest proposal of Dubling Rishi Dogri-Lamche Dogri Road are as under:
