With reference to the above subject, the Deputy Conservator of Forests, Tumkur Division, Tumkur submitted that to the above cited subject,in continuation of this office proposal has been submitted. The Chief Conservator of Forest, Ballari Circle raised the query towards an extent of 0.2654 ha, has been falls in Hosadurga Range, Chittradurga Division. Accordingly proposal has sent back to user agency directed that submit revised proposal.

User agency has submitted revised proposal for diversion of 2.260 ha forest land in Sy. No. 278 of Kenkere village, Huliyar Hobli, Bukkapatna Range, Tumakuru District.

The proposal was verified by me along with Range Forest Officer, Bukkapatna Range and Assistant Conservator of Forests, Tiptur Sub-division. The proposed unit of land measuring 2.260 ha falls in Sy. No. 278 of Kenkere village, Huliyar hobli, Chikkanayakanahalli Taluk, Bukkapatna Range, Tumakuru District.

An extent of 208-18 acre/gunta has been mutated as "Sarkari Forest" in Col No.-9 of R.T.C and adjacent to the Kudrekanive Reserve Forest. The said forest area falls under Eco Class-III with Central Dry Zone Deciduous type of Forests. There are 456 trees and shrubs in the proposed area.

Details of area requisited for diversion in proposal are tabulated as following;

The user agency has agreed to pay the cost of raising compensatory afforestation, net present value, lease rent as per the prevailing rates, the required forest land is barest minimum and unavoidable.

The User Agency has identified 5.0508 ha degraded forest land in Sy. No. 114 & 116 of Dasudi village, Huliyar Hobli, ChikkanayakanhalliTaluk for compensatory afforestation in lieu of proposal diversion of 2.5254 ha of forest land in Sy. No. 278 of Kenkere village, Huliyar Hobli, Chikkanayakanahalli Taluk, Bukkapatna Range and Hosadurga Range, Tumakuruand Chittradurga Divison.

The wildlife metigation plan as been submitted to the Principal Chief Conservator of Forests (Wildlife Warden) for approval. I have also visited the proposed area on 15.02.2023 along with concerned staff.

In view of the above facts and circumstances, The proposal for diversion of forest land is barest minimum and unavoidable, I recommend an area to an extent of 2.260 ha forest land in Sy. No. 278 of Kenkere village, Huliyar Hobli, Chikkanayakanahalli Taluk, Bukkapatna Range, Tumakuru District. Which is required for Reconstruction of two lane road with paved shoulders from Huliyar to K.B. Cross section and from K.B. Cross to Nelligere section of N.H-150A in the interest of public under Sec-2 of Forest (Conservation) Act-1980.

The proposal may be accepted since it is for public purpose. The proposal under section-2 of Forest (Conservation) Act 1980 is submitted for your kind perusal. Required information / documents are submitted in six sets for further needful action.
