Sub : Forest (Conservation) Act, 1980- Online forest clearance proposal for diversion of 5.5831Ha of forest area 5.5181Ha (Two segments) in Thoppur RF of Dharmapuri Range and 0.065Ha (Two segments) in Gummanur RF of Palacode Range in Dharmapuri Forest Division for laying pipeline under KKBMP L Tamil nadu section - Dharmapuri District - Submission of reply for the EDS raised / short comings pointed out - Regarding.

I herewith submit my replies as follows for the Query / short comings pointed out by the Principal Chief Conservator of Forests (HoFF), Chennai.

(P.T.O)

(i). The User Agency has uploaded the District Collector, Dharmapuri letter Ref.No.4904/2023/Tha2, dated.29.08.2024 under **section L, point no (f)** stating that the land transfer proposal has been sent to the Commissioner of Land Administration, Chennai for obtaining approval. However, on perusal of the uploaded Compensatory Afforestation land identified in the non forest land in SF.No.692/29, Extent.4.44.31Ha and SF.No.692/30, Extent.1.14.0Ha of No.18 of Kammampatty Village in Nallampalli Taluk of Dharmapuri District found with the presence of agricultural land. Thus, for necessary demarcation of the boundary. The Tahsildhar, Nallampalli has erected boundary pillars and stated that the identified CA land is free from encroachments and handed over the identified CA land for mutation to Forest Department vide Ref.No.1590/2024/E1, dated.04.12.2024. Accordingly, the Forest Range Officer, Dharmapuri has taken over the Compensatory Afforestation land identified in the non forest land in SF.No.692/29, Extent.4.44.31Ha and SF.No.692/30, Extent.1.14.0Ha of No.18 of Kammampatty Village on protection point of view as this land is adjoining to the boundary of the Parigam B reserved Forest in Dharmapuri Range.

However, if any queries / modifications to be required in the identified compensatory afforestation land in NFL during the field inspection by the officials from Government (DIGF(Central) / AIGF(Central)). Then, the necessary modifications will be carried out by the User Agency (Undertaking enclosed) in consultation with District Administration, Dharmapuri on priority basis.

(ii) The details of Compensatory Afforestation Scheme, KML file of the identified land for raising Compensatory Afforestation in Kadathur degraded forest area in Morappur Range, necessary Geo reference map showing the GPS points and Survey of india map, CA Estimates along with all CA Scheme documents have been uploaded under section 13 in PART II of Form - A. **But it is not showing in the Print / View report Summary Page.** Thus, All the required documents have also been uploaded under Additional information details section. This may kindly be considered and accepted for further process.

Therefore, i request that considering the importance of this project. The proposal for diversion of 5.5831Ha of forest area 5.5181Ha (Two segments) in Thoppur RF of Dharmapuri Range and 0.065Ha (Two segments) in Gummanur RF of Palacode Range in Dharmapuri Forest Division in Dharmapuri district for laying under ground Ø24" R-LNG pipeline may kindly be recommended and submitted for getting the stage I approval from the Government of India.
