Minutes of 8th Meeting of Regional Empowered Committee (REC) of Integrated Regional Office, Shimla held on 20th June, 2022- Case Diversion of 0.56 ha. of forest land in favour of Bhup Raj, 162/9 Bhojnagar Bajar Sundernagar, for the Construction of Dhanwan Small HEP (1.00 MW), within the jurisdiction of J/Nagar Forest Division, Distt. Mandi HP. [online no. FP/HP/HYD/39107/2019].

Memorandum:


Kindly refer to observation raised by REC meeting held on 29th June, 2022 received in this office through EDS dated 02.07.2022, on the subject cited above.

2. The point wise reply of the observations raised vide above referred communication have attended to by DFO J/Nagar/ User Agency, as under:-
1. The issue of review of aerial distance from Nagru Wild Life Sanctuary has been confirmed by the DFO Wild Life Division Kullu. Copy of the same is enclosed as Annexure "A".
 2. The user agency has intimated that transmission line is Double circuit line.
 3. The user agency has intimated that as per Revenue record "Measurement Unit" is "KARAM". For taking 5 Karam on lease, it comes to 7.1 mtr all over the State as against FCA approved plan of 7 mtr. In this connection it is submit that at the time of actual acquiring of land, he will adjust the width to 7 mtr. And give away the extra land, however also taking up the issue with the State Government as well as Government of India MoEF &CC, separately.
 4. The "KARAM" issue in width of trasmission line in the extant proposal should be brought by Nodal Officer Shimla to the notice of MoEF&CC at the time of submission of propossal to MoEF&CC for appropriate decision at Ministry level by IRO, Shimla.
 5. The user agency has intimated that the proposal was originally submitted by Sh. Bhup Raj but thereafter, the change of name from Bhup Raj to M/S Shivganga Hydel Power Project was done as per "Agreement of change of name" amongst the Special Secretary (NES), the Government of Himachal Pradesh-cum-DOE, Himurja, Shimla-171009, Shri Bhup Raj and M/S Shivganga Hydel Power Project on 29th September, 2021, copy of the same is enclosed herewith as Annexure "B".
 6. The Layout Plan showing all the components in distinct colours duly counter signed by DFO Joginder Nagar uploaded online Part 1 in additional information by user agency and enclosed herewith.

7. In this connext, it is submitted that there is no HEP approved/existing/proposed in the approved Hydel Project rivulet/nalla.
8. The Geo-referenced map, toposheet, CA scheme, land suitability certificate and Kml. file proposed for planting of 1120 trees by way of CA has been uploaded in online portal Part II at Para 13.
9. The reply to this point is given at point No. 1.

It is, therefore, requested that keeping in view of above facts necessary approval of the proposal under FCA, 1980 may kindly be obtained and conveyed to this office please.
