**SITE INSPECTION REPORT BY CCF, AJMER**

Name of Project: **Diversion of 0.1887 ha forest land for construction of approach road for a proposed retail outlet of IOCL along the NH-89 (Nagaur –Merta City ROAD)LHS, Part of khasra no. 209/108, at village Shubhdand, Tehsil Merta City, District. Nagaur, (Raj.).**

The site inspection of the land involved in the proposal has been done by me on dated **05.05.2021** on inspection of the site; it is found that land required by the user agency is a road side protected forest strip measuring **0.1887 ha**.
