With reference to the above, para-wise replies to EDS raised by IRO Kolkata vide No. IRO/KOL/WB/Others/154900/2022/474 dated 23/11/2022 as submitted by the User Agency and concerned DFOs are enclosed for kind consideration of forwarding to IRO Kolkata.

In this context, it is pertinent to mention that area of forest land proposed for diversion has been revised to 12.5492 ha. in Part-I in online portal. Part-II is still showing the incorrect unrevised total forest area of 17.6962 ha.

Wildlife Conservation Plan and Soil Moisture Conservation Plan area under preparation by DFO Burdwan. Specific intervention to treat the water effluent to drinkable standards should be included to avoid pollution of forest soil and water sources. The area is arid, and pumping out of underground water along methane is expected to affect the water table, and add to the water scarcity.

Processing is recommended for Stage-I approval by IRO Kolkata subject to above conditions please.
