The Deputy Conservator of Forests Koppal Division and Chief Conservator of Forests Ballari Circle Ballari reported vide (ref) (4) and (5) Details are as below.

1	Alternative examined are not provided.	The Deputy Conservator of Forests Koppal Division has reported that, The user agency has submitted three alternatives for the proposed pipeline, electricity lines and other buildings. All three options are being enclosed herewith. Option No II proposes the least forest area for diversion with 1.745 Ha. against the previously submitted proposal for 1.84 Ha. Earlier the number of trees to be felled was 40 in no's, however now with the submitted the option II no extra trees are to be felled except the previous once listed .
2	Feasibility of laying of pipeline on elevated structure may be explored so as to minimize the felling of trees.	As explained above the alignment of the pipeline has been changed with no felling of trees.
3	Location of break pressure tank is proposed in deep inside the forest area. Possibility of relocating the same at the initial point as done previously by other User Agencies, may be examined. If at all it is not possible to locate at the initial point then the same may be proposed in non-forest area / periphery of the forest area.	There is no proposal for the break pressure tank in the option II submitted. Hence no felling of trees involved.
4	Whether the validity of the consent given by the Water Resources Department vide order dated 09-11-2015 for drawl of water from Tungabhadra reservoir has been renewed as per the condition no. 24 of the said order. If so copy of the renewal document may be furnished.	The said order permitting withdrawal of water from Tungabhadra reservoir has been renewed vide GO No: Ja:sum:E:04: MTB:2018 Dated 04/02/2020 valid upto 14/07/2025. (copy enclosed)
