Proposal for diversion of 23.714ha. of Forest Land for Construction of Pandit Raghunath Murmu Medical College and Hospital in the District of Mayurbhanj under Baripada Forest Division.

In inviting a kind reference to the above cited memo on the captioned subject, the Divisional Forest Officer, Baripada Division vide his memo no.7582, dt. 07.11.2022 (copy enclosed) has submitted compliance report on the points raised vide your memo no.20336, dt.01.10.2022 for the project diversion of 23.714ha. of Forest Land for Construction of Pandit Raghunath Murmu Medical College and Hospital in the District of Mayurbhanj under the jurisdiction of Baripada Forest Division (Proposal No.FP/OR/DISP/148081/2021) to this office which is furnished below for favour of your information and necessary action.

- (i) **KML file of the forest area proposed for diversion and also of CA land needs to be furnished.**

**Compliance:-** In compliance to the point, the DFO, Baripada Division has submitted the KML file of the forest area proposed for diversion and also of CA land for the project in shape of CD which is attached herewith (3nos. CD).

- (ii) **Non-encroachment and non-encumbrance certificate of the CA land duly signed by concerned Tahasildar and DFO needs to be furnished.**

**Compliance:-** In compliance to the point, the DFO, Baripada Division has submitted the Certificate for Non-encroachment and non-encumbrance of CA land duly signed by the Tahasildar, Suliapada, Executive Engineer, Mayurbhanj(R&B) Division and DFO, Baripada Division which is enclosed herewith (3 Copies).

- (iii) In part-II of DP Column No.10(i), the CA land is mentioned as Govt. Non-Forest land and in site inspection report in column 17, it is mentioned as Govt. Forest land. In both the cases, it should be mentioned as degraded revenue forest land. This should also be mentioned in the Site Specific CA Scheme.

**Compliance:-**In compliance to the point, the DFO, Baripada Division has submitted the Revised Part-II and Site Inspection report accordingly which is enclosed herewith (3 copies of Part-II and Site Inspection report).

- (iv) The CA scheme over 49.952ha.(or 50ha.) of degraded revenue forest land has not been prepared basing on one-time cost norm. You are requested to prepare the CA scheme as per one-time cost norm & submit in 3 sets.

**Compliance:-**The DFO, Baripada Division has submitted the Compensatory Afforestation Scheme over 49.97Ha.(or 50Ha.) of degraded revenue forest land identified in Village-Kathasiris & Begunadiha of Suliapada Tahasil under Baripada Division with a total financial outlay of Rs.2,41,08,478/-( Rupees Two Crore Fortyone Lakh Eight Thousand Four Hundred Seventy Eight) only for raising Compensatory Afforestation with 10years maintenance at one time cost norm communicated vide memo no.20565, dt.01.12.2021 of Conservator of Forests (Nodal), O/o the PCCF & HoFF, Odisha, Bhubaneswar. The CA Scheme is enclosed herewith in 3(Three) Copies for approval.

Hence, 3(Three) copies of above documents is sent herewith for taking necessary action at your end.
