1	The land scheduled for Government land in Jharsuguda Town, Unit No.8 (Mallimunda village) authenticated by the Tahasildar Jharsuguda at Page No.63/DP found to be over 2 Nos of plots having total area 2.160 Ac. whereas the status of land schedule as on 25.10.1980 of Mallimunda village furnished at Page No.57/DP found to be over Plot No.73 only and plot No.73/3028 is missing.  Similarly, the land schedule of non-forest Government land involved in the project in Jharsuguda town, Unit.2 (Balijore village) at Page No.62/DP of total area 7.965 Ac. and the status of land schedule of the non-forest Govt. land of Balijore Mouza as on 25.10.1980 furnished at Page No.57/DP are not tallying. The status of Plot No.1700, 1688, 1679, 1290, 1289/ 12448, 1695/12450, 1291/12449 as on 25.10.1980 are missing.	The UA has submitted the revised land schedule as on 25.10.1980 both Govt. and Non-Forest Private land is enclosed at page No.55 to 61/DP.
2	Similarly, the status as on 25.10.1980 of the entire non-forest private land involved in the project over 4.098 ha. has not been furnished in the DP.
