Site Inspection Report

The proposed Compensatory Afforestation site (3.778 Ha) against the forest diversion proposal for 1.889 Ha of forest land for development drilling & exploratory location DPAB in Doyang Reserved Forest under Golaghat Division by ONGC, Jorhat is located at Deopani Reserved Forest of Sadiya Range under Doomdooma Division. As per direction of the undersigned this site was inspected by Sri Uttam Basumatary, AFS, DCF, O/o the Conservator of Forests, Eastern Assam Circle, Jorhat on behalf of the undersigned along with the RO, Sadiya Range on 20-09-2023.

During the inspection it was observed that the CA site (3.778 ha) is covered with shrubby vegetation and 110 nos. of saplings and 29 nos. of trees are scattered in the entire area. The trees standing in the selected alternative CA Site for DPAB (3.778 Ha.) area as follows:
