Proposal for diversion of 30.630 ha. of forest land (30.221 ha. in Deogarh Division and 0.409 ha. in Bonai Forest Division) under Forest (Conservation) Act,1980 for construction of Kala Barrage Irrigation Project across Kala Nallah by IB Investigation Division, Sundargarh (Proposal No.FP/OR/IRRIG/47353/2020 dt.1.2.2020 with State SI. No.OR/018/2020 dt.1.2.2020).

With reference to the captioned subject, the point-wise compliance of the deficiencies raised by the Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, F.C. Act' O/O the P.C.C.F., Odisha Bhubaneswar vide his Memo under reference (1) is furnished below in respect of diversion of 0.409 ha. of forest land in Bonai Forest Division.

1. The FRA Certificate issued by the Collector, Deogarh for forest land of 7.355 ha. & 19.908 ha. vide No.4962 dt.8.11.2019 and No.263/SSD dt.6.3.2019 respectively are in Form-I. So also the FRA certificate issued by the Collector, Sundargarh for 0.409 ha. of forest land enclosed in the proposal is found to be in Form-I. But the proposed Irrigation Project involving construction of a Barrage is no a linear project. Therefore, FRA certificate is to be submitted in prescribed Form-II.

In compliance to above said observation, the Collector, Sundargarh has requested vide this office Letter No.6887 dt.5.8.2020 to submit the F.R.A. Certificate in the prescribed Form-II in respect of 0.409 ha. of forest land in Bonai Division. However, the User Agency has submitted an undertaking to submit the F.R.A. in the prescribed Form-II soon after receipt of the same from the Collector, Sundargarh, which has been countersigned by the undersigned is attached as Annexure-I.

The English version of Grama Sabha Resolution has not been furnished.

In compliance of above said observation, the Collector, Sundargarh has requested vide this office Letter No.6887 dt.5.8.2020 to submit the English version of Gram Sabha Resolution in respect of 0,409 ha. of forest land in Bonai Division. However, the User Agency has submitted an undertaking to submit the English version of Gram Sabha Resolution soon after receipt of the same from the Collector, Sundargarh, which has been countersigned by the undersigned is already attached as Annexure-I.

3. The copies of SDLC and DLC proceeding along with Grama Sabha Resolution as per FRA 2006 pertaining to forest land involved in the project of Bonai Division is wanting.

In compliance of above said observation, the Collector, Sundargarh has requested vide this office Letter No.6887 dt.5.8.2020 to submit the copies of SDLC and DLC proceeding along with Gram Sabha Resolution as per FRA,2006 in respect of 0.409 ha. of forest land in Bonai Division. However, the User Agency has submitted an undertaking to submit the copies of SDLC and DLC proceeding along with Gram Sabha Resolution as per FRA,2006 soon after receipt of the same from the Collector, Sundargarh, which has been countersigned by the undersigned is already attached as Annexure-I.

4. The plot-wise Hal & Sabik Kissam of Non-forest land as on 25.10.1980 of 1.174 ha. of Banki Mouza under Bonai Division involved in the project may be furnished.
