As per the above referenced letter, No.2 the discrepancies observed in the proposal for diversion of 3.48 Ha forest land under FCA 1980 for Gravity Diversion Scheme Nanashi Link Cut/Canal in village Nanashi, Tal.Dindori, Dist Nashik, the User Agency & Deputy Conservator of Forests West Nashik have submitted their report vide above Ref No.3 & 4. The pointwise compliance is as follows.

1.0 DGPs/shape KML file for the area proposed for diversion and CA depicting viz- a viz village/ compartment/survey number wise details to shown in CD in their soft copies has not been submitted Further examination of the KML file for CA reveals density in form of forest cover Necessary clarification to be given in this regard.	DGPs/Shape KML file for the area proposed for diversion and CA depicting viz- a viz village/compartment /survey number wise details shown in CD (soft copies) are submitted herewith.
2.0 The DCF in part-II of from-A mentioned that he proposed for diversion has been noticed with the white Rumped vulture (Gyps bengalensis)Long Billed vulture (Gyps indicus) and common leopard is found in the area. Therefore comments of CCF (T) Nashik/DCF on the conservation if any required to be taken may be intimated.	Management of Wildlife Habitat due to Diversion of Land is submitted as follows 1) Leopard Rescue & Management plan for Rs.130.2 Lakhs 2) Vulture Conservation & Management (Gyps bengalensis, Gyps indicus) for Rs.40.5 Lakhs

5.0 Detail of alternative alignment explored by the User Agency has not been submitted A map showing the three alternative alignments explored by the User Agency in soft copies of KML/ Shape files of alignments needs to be submitted.	There is no alternative alignment available for link cut except the proposed alignment. The proposed alignment of link cut/canal is most economical and technically suitable. Justification regarding this is submitted on page No.88-89 in the proposal submitted by this office vide reference no.1
6.0 P/19 index map indicating forest land, non-forest land and adjoining land to the proposed for diversion to be shown in different colors has not been submitted.	Forest land and non-forest land for CA are too far from each other, can not be shown in one Index map topsheet. Hence separate Index maps and DGPSs Village maps showing forest land and non forest land have been submitted on page No.16-23 in the proposal submitted by this office vide reference no.1
