Sub: Proposal for use of 28.8 ha of forest land from buffer area of Ramgarh Vishdhari Tiger Reserve for widening of Laxmipura-Dora-Dabi-Ranaji Ka Guda NH-12 district-Bundi, Rajasthan-**FP/RJ/ROAD/29812/2017**.

Sir,

Reference is invited to the subject mentioned above. The above proposal was discussed in the 80th meeting of Standing Committee of National Board for Wild Life held on 9th October, 2024 under the Chairmanship of Hon'ble Minister for Environment, Forest & Climate Change.

2. After discussions, the Standing Committee decided to recommend the proposal subject to following conditions:

- I. The User Agency shall seek inputs from the forest field staff regarding the locations which are frequently used by wild animals for crossing the road and construct animal underpasses apart from those already proposed at the five locations. Particularly, in accordance with the guidance document, 'Eco-friendly measures to mitigate impacts of linear infrastructure of wildlife' for every km passing through the forest areas in the buffer zone, the user agency shall construct underpasses for wild animals for an overall extent of 50 m span which shall include underpasses of minimum 30m spans, box culverts, and hume pipe culverts. Wherever, the stretch of the road crossing the forest area in the buffer zone is less than one km, in such case also, the User Agency shall construct underpasses, box culverts, hume pipe culverts for an overall span of 50 m.
- II. Along these underpasses, on the both the sides of the road funnel shaped Random Rubble Walls shall be constructed to channelise the wild animals to pass through these underpasses.

- III. The User Agency shall provide funds for construction of two forest check posts one each near Dabi and Laxmipura.
- IV. No vehicle carrying the mined material shall be allowed to pass through this road from 6.00 pm to 6.00 am.
- V. The Forest Department shall devise a mechanism so that no vehicle carrying illegally mined material is allowed to use this road.
- VI. 2% of the proportional project cost falling within the tiger reserve shall be deposited in RPACS by the user agency for relocation of villages/land acquisition.
- VII. No work shall be done before sunrise and after sunset in the project area.
- VIII. No material of any kind shall be extracted from the tiger reserve.
- IX. There shall be no felling of trees and burning of fuel wood inside the tiger reserve.
- X. The waste material generated shall be disposed outside the tiger reserve.
- XI. There shall be no labour camp within 1 km from the boundary of tiger reserve.
- XII. No blasting shall be carried out within 1 km from the boundary of tiger reserve during the work.
- XIII. There shall be no high mast/ beam/search lights & high sounds within 1 km from the tiger reserve boundary.
- XIV. Signages regarding information about the wild animals in the area, control of the traffic volumes, speed etc shall be erected in the project area.
- XV. The User Agency and project personnel shall comply with the provisions of the Wild Life (Protection) Act, 1972.
- XVI. Maintenance activity of any nature shall be carried out only after seeking formal approval from competent authority of tiger reserve.
- XVII. The User Agency and project personnel shall comply with the provisions of Standard SOP/Guidelines issued by WII, Dehradun for linear projects.
- XVIII. Any permission/clearance required under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 or other acts may be taken as per rules.
- XIX. Sign boards shall be installed at every 500 meters in the sanctuary area. The details on the sign boards shall be posted after the approval of the Chief Wild Life Warden.
- XX. Speed breakers shall be made and marked with fluorescent paint at a distance of every 300 meters in the sanctuary area.
- XXI. An annual compliance certificate on the stipulated conditions shall be submitted by the User Agency to the State Chief Wild Life Warden and an annual compliance certificate shall be submitted by the State Chief Wild Life Warden to Government of India.


