Sub: Diversion of 23.983 ha of revenue forest land for construction of 220KV LILO Line from existing Bhanjanagar-Meramundali DC line to 220/33 KV GRID Substation at Daspalla from village Madhyakhanda to Gopalpur by M/s OPTCL under Nayagarh Forest Division of Nayagarh District, Odisha - GoI observations regarding.

Madam,

In inviting a kind reference to the above cited memo on the captioned subject, it is to inform that the Government of India, Ministry of Environment, Forest & Climate Change, Regional Office, Bhubaneswar has requested to furnish point wise compliances on the following points observed by them.

Observation (1): The DFO, Nayagarh Division has reported that no violation has been committed by the user agency under FC Act 1980. However as per DSS analysis the user agency has constructed 18 nos. of towers over the proposed forest land to be diverted without forest clearance. Detail action taken report on violation of FC Act 1980 alongwith name & designation of erring officials responsible for violation causing diversion of forest land for non-forestry purpose may be furnished.

Compliance: In compliance to the above the DFO, Nayagarh Forest Division has reported that 18 nos of towers have been constructed over the proposed revenue forest land without forest clearance, in that regard Tahasildar, Daspalla has booked 14 nos of encroachment cases against the user agency i.e. M/s OPTCL under OPLE Act. For causing violation regarding diversion of forest land for non-forestry purpose. In that regard action taken report on violation of FC Act 1980 furnished by The Tahasildar, Daspalla vide his memo No.748 dated.13.02.2024 addressed to the DFO, Nayagarh Division is enclosed herewith as **Annexure-A** for reference.

Regarding illegal construction of balance 4 nos of towers by the user agency, it has also been reported by the Tahasildar, Daspalla which has been revealed from his memo enclosed as **Annexure-A**, that those towers have been constructed over private land under three nos of villages.


Observation (2): Agricultural activities, artificial structures and a major metallic road are observed in CA patch at Nuagaon village. This may be clarified by the state Govt. In view of the suitability of CA land and encroachment free land.

Compliance: In compliance to the above the DFO, Nayagarh Forest Division has reported that regarding suitability of CA land for raising of CA at village Nuagaon, the Tahasildar, Khandapara Tahasil under Nayagarh District vide his memo No.685 dated.16.02.2024 addressed to the DFO, Nayagarh Division (enclosed as **Annexure-B**) has reported that the proposed land identified for raising of CA under this project is free from encroachment and encumbrance. In this regard the report of the revenue supervisor, Khandapara dated.15.02.2024 addressed to the Tahasildar, Khandapara Tahasil which is enclosed as **Annexure-C** may please be taken to consideration.

In view of the above it is therefore requested that the compliances to the observations made by GoI, MoEF& CC, Regional Office, Bhubaneswar dated 19.09.2023 is sent herewith for favour of kind information and necessary consideration for processing of the proposal.


