Dear Sir,

We are in receipt of letter dated 30th January 2024 wherein we have been informed that the reply submitted vide our letter dated 18th January 2024 regarding tentative timeline for payment of the 2% of NPV is not satisfactory. We have been directed to furnish specific comments regarding tentative timeline for payment of the 2% of NPV as sought by the IRO, Shillong vide letter dated 30.11.2023.

We were prepared to discuss and explain the issue in the meeting called by Principal Chief Conservator of Forests & Nodal Officer, FCA, Tripura at FHQ, Agartala on 22 February 2024 which was postponed to 1 March 2024 and later cancelled.

As already mentioned in our letter dated 22nd June 2023 (enclosed with letter dated 4th July 2023), in order to implement the approved Field Development Plan (FDP) for Kathalchari discovery, it is imperative for all the Conditions Precedent (CP) approvals (PML, Forest Diversion of Development locations- KL-Dev 34A 1, KL-Dev 37A, KL-Dev 37B & Dev 2A, Environment Clearance and PSC Timeline Extension) to be in place, as a single approval will not allow the Operator to take any step. Once all the approvals are received, the Operator would have to carry out a detailed reassessment and rework a realistic forward looking development and production plan which in turn may need to be approved by the respective managements of the Contractor Parties followed by review of the Management Committee.





Dear Sir,

The PML application for 249 Sq KM Kathalchari Development area was made on 30th August 2015 along with requisite fees immediately after MC approval of the FDP. Tripura State Government sent in their recommendation to MOPNG on 26th September 2015. DGH informed Contractor on 25th November 2016 that processing of PML has been put on hold pending payment of LD, which issue was then referred to arbitration by the Operator. It was only on 23 Dec 2019 that MOPNG approval for grant of PML for Kathalchari development area was received. This was followed by grant of Petroleum Mining Lease by Directorate of Industries & Commerce, Government of Tripura vide their letter dated Sep 24, 2020. However, the PML so issued was not in compliance with MOEF guidelines wherein Central Government approval under FCA Section 2(iii) is required for the forest area falling under PML before PML can become valid. In accordance with MOEF guidelines, Operator initiated process to obtain approval under FCA 2(iii) and uploaded the proposal with all required documentation on MoEF &CC portal on Dec 2, 2021. As the Tripura State Forest Department did not accept the maps prepared using available information and directed to prepare maps basis site survey. The maps were duly prepared and verified by Tripura Forest Department GIS Lab in Nov 2022. Meanwhile, MoEF notified FC Rules 2022. Sub Rule 5 (a) of Rule 9 of the Forest (Conservation) 2022 provides that, no approval is required for assignment of Petroleum Mining Lease where neither physical possession nor breaking of forest land is involved. Operator thereafter wrote to Nodal Officer (FCA), Tripura to kindly advised us the procedure for further course of action.



Contractor in various meetings and communications, has informed DGH that the commencement of KL development activities could not be undertaken due to various statutory and regulatory issues including lack of government approvals required to commence and progress development activities. Due to the inordinate delay in grant of CPs, Operator had no other option but to disband in a phased manner its operations team and other resources at site, in order to minimize its costs. Further the FDP approved by Government in August 2015, will need to be re-evaluated keeping in view material changes in costs and time of various activities that may have taken place during this intervening period.

In order to implement the development plan, it is imperative for all the approvals to be in place as a single approval will not allow Operator to take any step. Once all approvals are achieved, Operator would have to carry out a detailed reassessment and rework a realistic forward looking development and production plan which in turn may need to be approved by the respective managements of the Contractor Parties followed by review of the Management Committee. The Contractor Parties are ad idem with respect to this way forward. In the recent OC meeting held on 26 May 2023, the Contract Parties agreed that the PML NPV payment could only be made after all the CPs have been met and that the NPV payment should be kept in abeyance till then.

This is in connection with the alternate Compensatory Afforestation site in lieu of 1.368 ha of forest land for construction of Drill site, Waste pit, Drill site Accommodation, TSR Camp and its approach road for location called DEV-2A.

I had visited the site along with the Shri Babul Mog, TFS (SDFO Bagafa) and Shri Sekhar Lodh, FR (RO Kakula) on dated 3rd January 2024. The details of the site were verified as follows,

The selected CA site of 1.368 ha is located under Baramura Debtamura RF under Kakulia



Forest Range of Bagafa Forest Subdivision under South Forest District. This CA site is mostly covered with Cylindrica imperata locally know as "Chhan ghas" and weed like Chromolaena odorata. These two weed are commonly found weeds in the jhum abandoned forest land in Tripura and posing great problem for restoring the ecosystem naturally.

Anogeissus acuminta, Schima wallichi are in the identified plot. In addition, few coppices of Tectona grandis are also found inside the plot. But the canopy cover of all these standing trees inside the identified CA land is below 10% and the density is under the category of open degraded forest.

Thus, based on the observations made during the visit, it is to certify that the proposed site with is recommended for Compensatory Afforestation.
