

BT road from Vanjariguda to Geethabanda









1. INTRODUCTION:

The total geographical area of Telangana State is 114840 Sq KM and the total forest area is 28809.08 Sq. Kms. which constitute to 25.19%., whereas the total geographical area of the Asifabad Division is 2,85,304 Ha covering the forest area of 1,53,810.54 Ha in (6) Ranges constituting about 53.91 %.

The Asifabad Division consisting of (6) Ranges, namely – (1) Asifabad, (2) Rebbena, (3) Tiryani, (4) Ginnedhary, (5) Jodeghat and (6) Kerameri Ranges.

The Forest area in the Ranges are being utilized as the Jodeghat and Ginnedhary Ranges are serving as "Core & Buffer area" of Kawal Tiger Reserve, apart from that the Forest area in the Asifabad, Kerameri and Rebbena Ranges are being utilized as "Corridor for Kawal Tiger Reserve" for attracting the Tigers from Thadoba Tiger Reserve of Maharashtra State and Indiravathi Tiger Reserve of Chattisghar State.

In the above scenario the Executive Engineer, R&B Division, Kumuram Bheem-Asifabad submitted proposals for Construction of BT Road from Vanjariguda to Geethabanda from Km 0/0 to 2/958 of Lingapur Mandal , Kawal RF. 
