User Agency have to hand over 9.19 ha non-forest land to Forest Department and at least 9190 no. of plants need to be planted on the same. However, in case 9190 no. of plants cannot be planted on the said CA land then balance number of plants should be planted over a degraded Forest land Accordingly, the State Government shall submit KML files for 9.19 ha non-forest land and required DFL along with their CA seliemes. CA suitability certificate and Differentail GPS map.

Holdarnagar Nashik Range in area 9.19 ha with workable area 4.00 ha. Here 4444 plants will be Planted.

And the balance Plants will be Planted on degraded forest land Comp. No. 247 Village Vilvandi Peint Range with area 5.19 ha. Here 5766 plants will be planted.

The Estimates & K.M.L file of afforestation site i.e Gut. No. 13 Holdarnagar & Comp. No. 247 Vilvandi is submitted alongwith maps.
